2021 was a challenging year due to the pandemic and the worst economic recession since the Great Depression. Within the Center's service area, an estimated 60,000 people live in poverty. Unemployment spiked last year and still remains around 10% locally. In our area, housing costs are three times the national average. Nearly a third of families in our communities pay more than half their income for rent. Many working poor families are struggling daily to not slip into homelessness.

The number of people affected by poverty and needing our help grew significantly. We were faced with ever-changing safety measures and fears. Through it all the

Center never closed its doors. We added new services such as COVID-19 testing, vaccinations, and provided masks and supplies. We provided seven times more food deliveries than pre-pandemic 2019. Our comprehensive range of services, Food, Health, Crisis Case Management, Housing/Homeless and Job Development, continue to provide a comprehensive safety net.

In these tumultuous times, we continue to rise with compassion to "Be the Heart of Hope" to our neighbors in need. This summer, Foothill Unity Center was honored and awarded "Non Profit of the Year- Heroes of the Pandemic" by Congresswoman Judy Chu.

Through the power of our community, team effort and generous donations from all our supporters, the Center will continue to make life-changing differences for neighbors in need. Together, we will stay true to our value of Neighbors Helping Neighbors.



**COVID-19 IMPACT**

For over 40 Years, Foothill Unity Center has helped individuals and families in need with programs that focus on: Food, Health, Crisis Case Management, Job Development, Housing and Homeless services, supported by our Volunteer Program.

## MISSION

We help neighbors in crisis attain self-sufficiency by partnering with the community and using our resources wisely to provide vital support services with love and dignity.

## VISION

## HISTORY

Foothill Unity Center was founded in 1980 by Josephine Anderson in a borrowed church closet in Monrovia, California, to provide food to a few hungry families. Over the years the Center has become a major source of food, health services and crisis assistance for thousands of low-income families. In 1991, the Center was incorporated as a 501(c)(3) non-profit organization. In 2008 we were federally designated the Community Action Agency for the Foothill Area of Los Angeles County.

## COMMUNITY ACTION PARTNER

As the Community Action Agency of the Foothills, Foothill Unity Center is the region's largest distributor of nutritious food to very low-income families. Food donations from our partners at the Los Angeles Regional Food Bank, local merchants, and non-profits, together with food purchased by the Center, fill a basic need in our community.



## AMERICORPS VIP SUPERVISING ORGANIZATION

As a partner of CalSERVES, Foothill Unity Center functions as the Supervising Organization that oversees AmeriCorp VIP Fellows at the local level. Complex needs facing our local communities include education, employment, health access, housing, hunger, and wealth inequities. Fellows build capacity by providing support, skills and resources to not only address these needs, but to assure volunteers are successful as they provide service to the community.

## COMMITTED TO TRANSPARENCY AND ACCOUNTABILITY

Foothill Unity Center is proud to be recognized for our services and our impact on the community. We have received top ratings from charity watch dogs and positive reviews from the community. 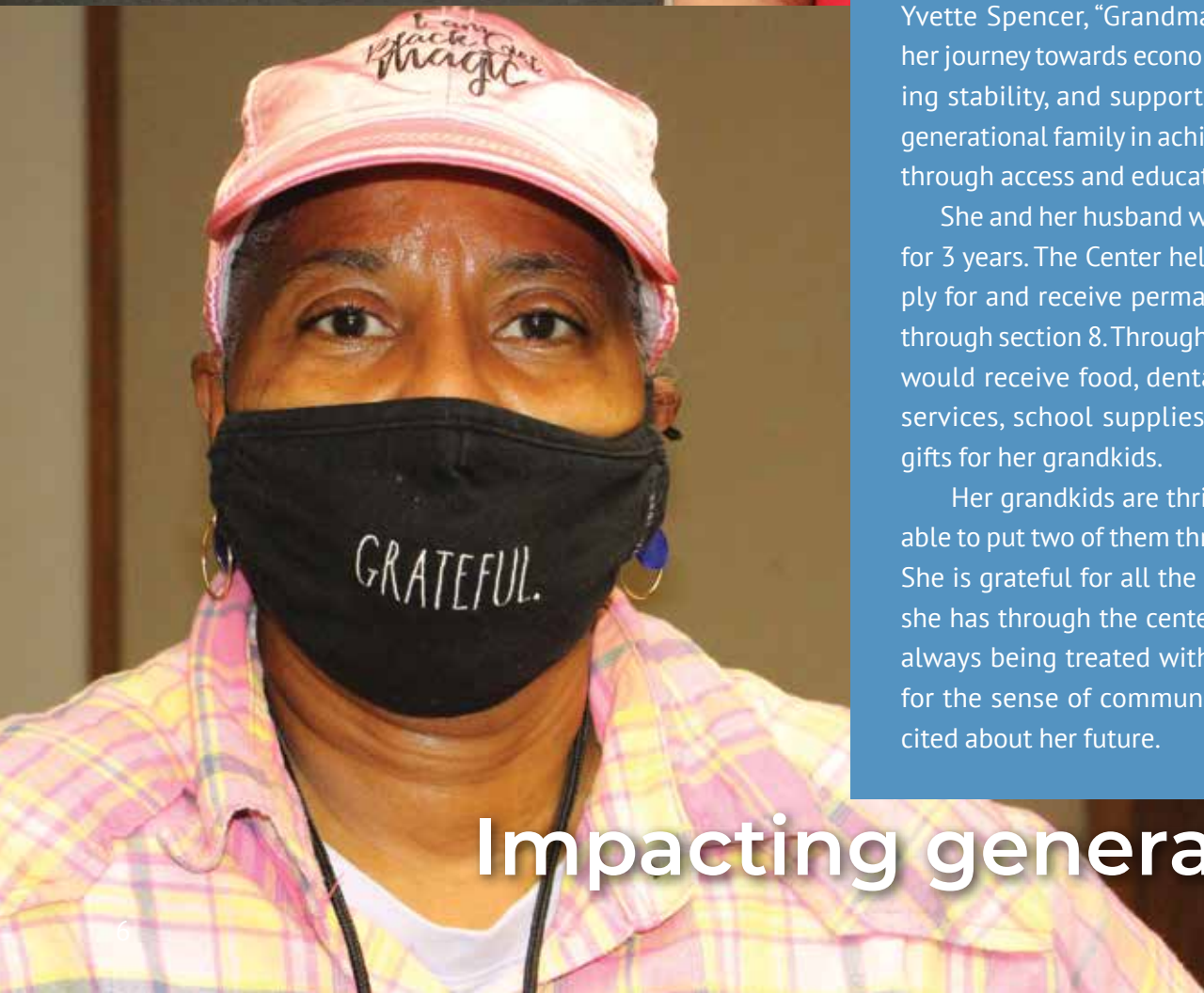
## YVETTE'S STORY

# Bringing Comfort

## ELAINE'S STORY

Elaine Iverson has a passion for making quilts and helping those in need. She has consistently donated quilts every month for over 2 years for our homebound and senior clients who wait eagerly for the next collection of warm blankets to arrive.

In her own words, "It is so special to see people appreciating the quilts, one mother said to me that her daughter won't go anywhere without her blanket [...] that really touched my heart. Seeing people find comfort in the quilts I make is what urges me to keep making them. There are so many people in need and a hand-made quilt can keep people warm and it gains so much more meaning along the way."



## JUSTENE'S STORY

Justene, mother of five, was chronically homeless since 2017, staying with friends, family, hotels, and shelters. In 2018 she was at Union Station shelter when she gave birth to her child in the dark.

In 2020, she found Foothill Unity Center and was assigned a social worker where she finally found a sense of community and care. She was placed in an extended stay, with a kitchen and fridge that gave them time to recover from the trauma of homelessness and she was able to save money and heal. She received behavioral health support, kids' school supplies and backpacks, clothes, food, holiday gifts for the kids, therapy, and step-by-step help applying for and receiving permanent housing through section 8.

In her own words "They made me feel as if it was my family taking care of me. My faith in humanity is seriously restored. You've given me this chance at life and offered me new cycles of healing that I never thought I would have."

More than half of older women living alone – 54% – are in a similarly precarious financial situation: either poor according to federal poverty standards or with incomes too low to pay for essential expenses. For single men, the share is lower but still surprising – 45%.

# FOOD PROGRAM

Many neighbors in our community are one job loss or medical crisis away from food insecurity. Foothill Unity Center leads the fight against hunger and poor nutrition in the San Gabriel Foothills through our food distribution, community kitchen and nutrition education programs.

Includes food for a week for those who have the means to re-frigerate and cook food, plus bag lunches and hygiene kits for those experiencing homelessness. Food boxes are delivered to seniors, homebound, and disabled clients who cannot drive. Thanksgiving and Holiday Food Distributions are special events that are added to the food distribution.

We continue to be driven to improve the quality of our food and services. In 2021, after a year and a half of extensive training, our Center was awarded the title of Nutritious Food Pantry by LA Regional Foodbank.

# HEALTH PROGRAM

Access to healthcare, education on ways to manage chronic health diseases, and assistance with navigating the healthcare system.


Among the other services we provide are dental and vision screenings, dental procedures, eye exams, glasses, and eye glass vouchers from mobile and on site dental and vision clinics, flu vaccines, glucose/diabetes screenings, blood pressure screenings, nutrition, physical and mental health, and education that includes workshops, classes, exercise groups, and healthy cooking/recipe demonstrations and flyers. We leverage our workforce annually with over 100 work trainees, nursing students pursuing licenses, and interns in social work and public

The driving strategy and standard of care practice that supports our core programs through assessment, case planning, care coordination, advocacy, resource linkages, and follow up. Individualized client plans allow the case managers to track progress and make adjustments specific to personal situations. Case management provides access to a complete continuum of services, a safety net that improves the odds of success for an individual to move from poverty to economic security.

# JOB DEVELOPMENT PROGRAM


Helps to improve the economic lives of individuals with hands on assistance to gain employment for those unemployed and underemployed. The program aims to reduce the barriers to employment and help the whole family, thereby ending the cycle of poverty for the next generation. Annually, we supervise work experience trainees and interns, including at-risk youth, transitional youth, adults and seniors.

Local pet shelters are overflowing because people struggling to survive cannot afford to feed or take care of their pet's healthcare needs. Our Pet Food Bank helps hundreds of families keep their beloved pets. Our primary care pet clinics with the Pasadena Humane Society are hosted several times a year. Clients are able to visit with a veterinarian, ask questions and receive care for their beloved pets.

## MOBILE DENTAL CLINIC

Our annual Mobile Dental Clinic in partnership with the Herman Ostrow School of Dentistry of USC, provided over one hundred pre-registered low-income and under insured children and adults with comprehensive dental treatments, preventive measures and education.

Our Annual Thanksgiving and Holiday Distributions help to make the Holiday season brighter for local children and families in need. Families receive huge holiday food boxes for both distributions events, as well as new toys, clothing and gift cards for their children at our holiday event.
